## CRITERIA FOR SUBMITTING PAPERS

*Problema* will publish contributions in English or Spanish relating to Legal, Political and Moral Philosophy topics, in one of the following sections of the journal: *Discussion Topic, Articles* or *Review Essays*. The *Discussion Topic* section includes papers usually made by invitation only. Contributions for the *Articles* section will be subject to a double-blind peer review. *Review Essays* can also be submitted and will be published prior approval by the editor.

All contributions submitted for publication must be unpublished and formatted in Microsoft *Word* for Windows and meet the following requirements:

1) Bookman Old Style 12 point font, text justified on both margins, line spacing of 1.5, and page numbers centered at the bottom.

2) All contribution, except review essays, must include an abstract of 150-200 words and four to five keywords which reflect the main ideas of the paper.

3) References must appear at the foot of the page, in *Bookman Old Style* 10 point font, justified, single spaced, according to the following format:

- References to books will start with author's last name and first name, book title in italics, edition (if indicated), translator (if necessary), place of publication, the name of the publisher, date of publication, and page numbers (see note 1 below).
- References to journal articles will begin with author's last name and first name, article title in quotation marks, journal name in italics, place of publication, volume, issue, date of publication, and page numbers (see note 2 below).
- To refer to the same author (having only one work in the article) in no immediate subsequent footnotes, it will be enough to mention his last name, followed by the abbreviation "*op. cit.*" (in italics), and the referred page (see note 3 below). To refer to an author with more than one work cited in the article, use the author's last name, followed by a short version of the title, the abbreviation "*loc. cit.*" (in italics), and the page being referred (see note 7 below).
- When the citation comes from the same work as in the immediate preceding footnote, but not the same page, use the Latin word "*ibi*-

*dem*" (in italics), which means "in the same place", and the page being referred (see note 8 below).

- When the citation comes from the same work and the same page, as in the immediate preceding footnote, use the Latin word "*idem*" (in italics), which means "the same" (see note 9 below).

4) Bibliography will follow the format for footnotes, but in this case, the author surnames in Small Caps.

6) Submissions should mention contact information: e-mail address, telephone number, post address, and current academic position.

All papers submitted for the articles section will be subject of double-blind peer review. Reasons given priority for publication are: originality, quality, and argumentative soundness.

If an article is recommended for publication but with revisions and/or corrections, the author will be informed and asked to respond to these revisions and/or corrections during the following 20 days. Once this is done, the article is again sent to the reviewer or reviewers for comments on the modifications made.

In case an article is evaluated as "Publishable" by one examiner and "Non-Publishable" by another, *Problema's* editor-in-chief will send the article to a third examiner which, in turn, will settle a final result. When both examiners opinions are negative, the author will be immediately informed that his collaboration has been declined. All decisions are final.
